# EXECUTIVE ORDER NO <u>26</u> Series of 2021

PROVIDING FOR DECLARATION OF EXTREME LOCALIZED COMMUNITY QUARANTINE IN PUROK 3 MOLERA COMPOUND, BRGY. SUCAT AND PUROK 7 BEATRIZ COMPOUND, DE MESA L & B ST., BRGY. ALABANG, CITY OF MUNTINLUPA, AND FOR THE PARAMETERS OF CONCERNED DEPARTMENTS IN THE ENFORCEMENT THEREOF

WHEREAS, Section 2 of Executive Order No. 112 states that beginning May 16, 2020, all decisions to impose, lift, or extend community quarantine implementations in Provinces, Highly Urbanized Cities (HUCs), and Independent Component Cities (ICCs) shall rest with the IATF;

WHEREAS, IATF Resolution No. 35, Series of 2020, City/Municipal LGUs shall be allowed to declare the classification of Barangays based on risk thresholds subject to the confirmation of RIATF;

WHEREAS, Resolution No. 5, Series of 2020, issued by the Regional Inter-Agency Task Force - NCR (RIATF) dated 25 May 2020, provides for the requirements for LGU Appeals for Classification of LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

WHEREAS, on 13 August 2021, the City Health Office (CHO), through Juancho H. Bunyi, MD, Acting Head, recommends the imposition of Extreme Localized Community Quarantine (ELCQ) covering Purok 3 Molera Compound, Brgy. Sucat due to the incidence of 5 active COVID-19 cases. The community has 21 individuals, reporting a clustering of cases, with high attack rate of 238 per 10,000 population, and narrow doubling time of 2.0 days. Moreover, the community has a high population of senior citizens, person with disabilities, and children.

WHEREAS, on 13 August 2021, the CHO similarly recommends the imposition of ELCQ covering Purok 7 Beatriz Compound, De Mesa L&B St., Brgy. Alabang due to the incidence of 10 active COVID-19 cases. The community has 176 individuals, reporting a clustering of cases, with high attack rate of 568.18 per 10,000 population, and narrow doubling time of 2.0 days. Moreover, the community has a high population of senior citizens, persons with disabilities, pregnant women, and children.

**NOW THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa,** by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1: Declaration.

An Extreme Localized Community Quarantine (ELCQ) is hereby declared over the following communities, namely:

- (a) Purok 3 Molera Compound, Brgy. Sucat; and
- (b) Purok 7 Beatriz Compound, De Mesa L&B St., Brgy. Alabang

and this shall be effective from 6:00 PM of 13 August 2021 to 6:00 PM of 27 August 2021, for period of 14 days. This may be cut to an earlier date should conditions be ideal for such a declaration.

#### Section 2: Functions

In order to ensure the successful containment of the corona virus among the residents on the areas above-mentioned, the following offices shall perform the functions enumerated below:

# A. Philippine National Police - Muntinlupa City Police Station

Provide round-the-clock and overall security of the residents and personnel assigned and ensure peace and order.

#### B. City Health Office

Provide rapid antigen and RT-PCR testing kits and concerned personnel to conduct the same among the residents, ensure that the results thereof are properly handled, and provide all logistical support for the general well-being and health of all residents.

#### C. Ospital ng Muntinlupa

Provide the tertiary medical care, when warranted, and the isolation units, as deemed necessary.

#### D. Department of Disaster Resilience Management

Provide the logistical requirements of all departments and offices operating in ELCQ.

#### E. Social Services Department

Provide relief food packs, which shall be forwarded to the concerned Barangay, who in turn shall be responsible for distribution to the affected families.

## F. City Planning and Development Office

Provide relevant, timely and necessary data to assist the work done by all concerned departments.

#### G. Public Information Office

Facilitate the dissemination of relevant, correct and necessary information to the concerned offices and agencies, release press briefings and update proper media channels on the enforcement of ELCQ.

### H. Environmental Sanitation Center

Ensure compliance to environmental laws in the implementation of the quarantine, the cleanliness of surroundings, and proper waste disposal.

I. DILG - Muntinlupa City Local Operations Office

Ensure that all concerned departments and offices comply with the requirements set forth by Regional IATF.

J. Barangay Government of Sucat and Alabang

Provide necessary support in terms of law enforcement, peace and order, especially considering the density of the human population in the areas of distribution of relief food packs, medical supplies, as necessary.

Section 3. Separability Clause

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 4. Effectivity Clause

This Executive Order shall take effect immediately upon its signing and it shall remain in full force and effect unless repealed, revoked, or amended accordingly.
