EXECUTIVE ORDER No. 09
Series of 2021

**PROVIDING FOR PROHIBITION IN THE OPERATIONS OF SPAS, GYMS,
FITNESS CENTERS AND INTERNET CAFES, IN THE CITY OF MUNTINLUPA**

WHEREAS, Resolution No. 104, Series of 2021, issued by the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases, and dated 20 March 2021, under Item B.f. thereof, provides that *"(t)he suspension of operations of businesses/industries pursuant to IATF Resolution No. 103 issued on March 18, 2021, is hereby reiterated. The operations of driving schools, traditional cinemas, and video- and interactive- game arcades, archives, museums, and cultural centers, limited social events at accredited establishments of the DOT, and limited tourist attractions except open-air tourist attractions shall be temporarily suspended. Cockfighting and cockpit operations, including in areas under Modified General Community Quarantine shall be temporarily suspended. Venue capacity of outdoor dine-in restaurants and cafes, personal care services shall be reduced to a maximum of fifty percent (50%);"*

WHEREAS, Memorandum Circular No. 21-08, Series of 2021, issued by the Department of Trade and Industry (DTI), dated 28 February 2021, under Annex A, made an integral part thereof, provides that, under areas placed in General Community Quarantine (GCQ), personal care services shall operate at 75% capacity, wherein all services are allowed, subject to strict physical distancing, and gyms/fitness studios shall operate at 75%, wherein it is limited to individual workouts only, and group workout sessions composed of two (2) or more persons (e.g., zumba, yoga, pilates, etc) shall be strictly prohibited;

WHEREAS, in a meeting held among the Local Chief Executives of the cities and municipality of the National Capital Region (NCR) on 21 March 2021, it was collectively decided to impose further restrictions on top of the foregoing provisions because of the surge of covid-19 cases in the NCR; .

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Declaration of Prohibition.

The operations of spas, gyms, fitness centers and internet cafes, in the City of Muntinlupa shall be prohibited from 23 March 2021 to 04 April 2021.

Section 2. Violations.

Violators shall be dealt with applicable and relevant law, rules and regulations.

Section 3. Repealing Clause.

Previous orders or directives inconsistent with any provision found herein shall be deemed repealed, revoked or amended accordingly.

Section 4. Separability Clause.

In the event that any provision found herein is judicially decided illegal or administratively declared infirm, untouched provisions shall remain in full force and effect.


Section 5. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and it shall remain in full force and effect until repealed, revoked or amended accordingly.
