

AN ORDINANCE APPROVING THE SANGGUNIANG KABATAAN (SK) BUDGET FY 2022 OF BARANGAY TUNASAN, AMOUNTING TO NINE MILLION THREE HUNDRED FIFTY THOUSAND (PHP9,350,000.00)

WHEREAS, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) "Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.";

WHEREAS, the Budget Office endorsed to the Sangguniang Panlungsod the 2022 Annual Budget of Sangguniang Kabataan (SK) Tunasan amounting to *Nine Million Three Hundred Fifty Thousand (Php9,350,000.00)*;

WHEREAS, the City Budget Office endorsed the approval of the SK Budget of Barangay Tunasan which is complied with the rules and regulations, and providing laws on budget;

WHEREAS, appropriation for SK shall be disbursed in accordance with Art. 425 of the IRR, R.A. 7160 and R.A. 10742 otherwise known as the Sangguniang Kabataan Reform Act of 2015 and its IRR, and DBM-DILG-NYC JMC No. 1 Series of 2019;

WHEREAS, all procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provision of R.A No.9184 (Government Procurement Reform Act) and its Revised IRR; and prior clearances from pertinent agencies as maybe appropriate (needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

WHEREAS, the herein budget shall be available exclusively for the specific purposes for which it has been appropriated and shall be spent solely for public purposes. Thus, no monies shall be paid out of SK Treasury except in pursuance of an Appropriation Ordinance or Law;

NOW THEREFORE, BE IT ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa, to approved the SK Budget FY 2022 of Barangay Tunasan, amounting to *Nine Million Three Hundred Fifty Thousand (Php9,350,000.00)*.

ENACTED, by the 9th Sangguniang Panlungsod of Muntinlupa this 11TH day of April 2022, on its 144 Regular Session.
