ORDINANCE NO. 2022-027-A

AN ORDINANCE ON THE INCREASE IN THE GRANT OF ASSISTANCE TO STUDENTS SEEKING NATIONAL CERTIFICATION FOR NON-DEGREE OR VOCATIONAL/TECHNICAL COURSES UNDER THE MUNTINLUPA CITY TECHNICAL INSTITUTE (MCTI), AMENDING FOR THIS PURPOSE SECTION 15 OF ORDINANCE 17-107 OTHERWISE KNOWN AS AN ORDINANCE PROVIDING FOR AN EXPANDED MUNTINLUPA SCHOLARSHIP AND EDUCATIONAL ASSISTANCE PROGRAM AND OTHER INCENTIVES TO STUDENTS, PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES.

WHEREAS, Article 14, Section I of the 1987 Philippine Constitution, provides for the protection and promotion of the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

WHEREAS, further, Paragraph (3) of Section 2, Article 14 of the aforesaid Philippine Constitution also provides for the establishment and maintenance of a system of a scholarship student loan programs, subsidies, and other incentive which shall be available to deserving students in both public and private schools, specially to the under-privileged;

WHEREAS, Paragraph (a) of Section 458 of Republic Act 7160 otherwise known as the Local Government Code of 1991, also provides that, "The Sangguniang Panlungsod as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants;

WHEREAS, pursuant to the Rules and Regulations Implementing the LGC 1991, particularly Article 99 (5) (xi), provides, "establish a scholarship fund for poor but deserving students in schools located within its jurisdiction or for students residing within the city;"

WHEREAS, on July 17, 2017, the Sangguniang Panlungsod enacted Ordinance 17-107 or An Ordinance Providing For An Expanded Muntinlupa Scholarship And Educational Assistance Program And Other Incentives To Students, Providing Funds Therefore And For Other Purposes, where, under Section 2 thereof, student seeking national certification for non-degree or vocational/technical courses under the Muntinlupa City Technical Institute (MCTI) is subsidized with the amount ranging from Php 500.00- Php 1,700.00;

WHEREAS, in November of 2021, the Technical Education Skills Development Authority (TESDA), in a Board Conference held, resolved to standardize the assessment fees for various courses/qualifications and from thereon issued TESDA Circular No. 019 Series of 2022 dated 21 March 2022 which reads, "In the interest of service and to standardize the assessment fees among the stakeholders, the TESDA Board has approved and promulgated the assessment fees for various qualifications;"

NOW BE IT ENACTED, by the **10**th **Sangguniang Panlungsod of Muntinlupa** duly assembled the following:

SECTION 1. Title. This ordinance shall be known as the Increase In The Grant Of Assistance To Students Seeking National Certification For Non-Degree Or Vocational/Technical Courses Under The Muntinlupa City Technical Institute (MCTI);

SECTION 2. Schedule of New Assistance. The standardized TESDA assessment fees as the basis of the new assistance to covered students is hereby made an integral part of this ordinance. Thus, Section 2 Number 15 of Ordinance 17-107 which reads:

"National Certification Assistance to Muntinlupa City Technical Institute and Muntinlupa Senior High School Students. Granted to students seeking national certification for non-degree or vocational/technical courses under the TESDA/DEPED program. The expense per reviewer shall be paid by the City Government subject to the approval of the City Mayor upon recommendation of the director of the MCTI in coordination with the Muntinlupa Scholarship Program (MSP). The amount will range from Php 500.00- Php 1,700.00;

SHALL NOW BE READ AS FOLLOWS:

"National Certification Assistance to Muntinlupa City Technical Institute and Muntinlupa Senior High School Students. Granted to students seeking national certification for non-degree or vocational/technical courses under the TESDA/DEPED program. The expense per reviewer shall be paid by the City Government subject to the approval of the City Mayor upon recommendation of the director of the MCTI in coordination with the Muntinlupa Scholarship Program (MSP). The amount will be based on the prevailing TESDA Assessment Fees (N).

SECTION 3. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


SECTION 4. *Repealing Clause.* All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 5. *Effectivity Clause* – This ordinance shall take effect after its completion of its publication in a newspapers of general circulation.

SECTION. *Publication.* This Ordinance shall be published pursuant to the requirements of the Local Government Code and shall be posted by the Public Information Office (PIO) in the Official Website of the City Government of Muntinlupa and in all available social media platforms.
