AN ORDINANCE GRANTING THE TOTAL AMOUNT OF NINETY-TWO THOUSAND PESOS (PHP92,000.00) OF FINANCIAL ASSISTANCE TO THE SEVENTEEN (17) FAMILIES AFFECTED BY FIRE ON FEBRUARY 11, 2023 AT NO. 530 HACIENDA ROSARIO PUROK 2, BARANGAY SUCAT, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *the Sangguniang Panlungsod shall “Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *February 11, 2023 six (6) structures, consisting of seventeen (17) families*, were gutted by fire at *No. 530 Hacienda Rosario, Purok 2, Barangay Sucat, Muntinlupa City*;

WHEREAS, in a final report rendered by the Social Services Department on *February 13, 2023*, the following were noted as casualties of the said fire:

1. *Six (6) structures;*
2. *Seventeen (17) families;*
3. *Fifty-Three (53) individuals;*
4. *Four (4) Senior Citizen;*
5. *Two (2) Children (0-5 years old);*
6. *Two (2) Persons with Disabilities;*

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Sucat**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Ninety-Two Thousand Pesos (Php92,000.00)** financial assistance to be distributed as follows:

NOW, THEREFORE, BE IT ORDAINED, AS IT HEREBY ORDAINED, by the 10th **Sangguniang Panlungsod**, to grant the total amount of **Ninety-Two Thousand Pesos (Php92,000.00)** of financial assistance to the **seventeen (17) families** affected by fire on February 11, 2023 at **No. 530 Hacienda Rosario Purok 2, Barangay Sucat, Muntinlupa City.**

FURTHER, that the **Final Disaster Report** dated February 13, 2023 CN: 2023-002 issued by the **Social Services Department (SSD)** shall form part of this ordinance.

ENACTED, by the 10th **Sangguniang Panlungsod of Muntinlupa** this 20th day of **February 2023**, on its 33rd **Regular Session.**
