WHEREAS, Article XIII, Section 2 of the 1987 Constitution provides that "The promotion of social justice shall include the commitment to create economic opportunities based on freedom of initiative and self-reliance;"

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "The City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod pursuant to law or ordinance;"

WHEREAS, Section 16 of the LGC provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"

WHEREAS, the National Housing Authority (NHA) in the Livelihood Affordability Enhancement Program (LAEP) Operations Manual approved in 09 May 2017, under the LAEP Framework, during the post relocation phase / settlement phase, its states that the Community Support Services Unit – Socio Economic Development Division (CSSU-SEDO) is tasked to strengthen its Livelihood Program in partnership with the receiving Local Government Unit (LGU);

WHEREAS, the **City Government of Muntinlupa (CGM)** is deemed to have the capability and resources to assist the NHA in providing opportunities to its housing beneficiaries through the development and upgrading of their skills, employment facilitation, establishment of urban farms, public market administration, and cooperative establishment and development so they can attend to their own livelihood once they are settled in their corresponding resettlement sites;

WHEREAS, the **scope of agreement** mainly includes the provision of livelihood programs and support services *for socio-economic upliftment of the relocated families* and the commitment to share the resources in accordance with the established policies, guidelines, and procedures for the benefit of the resettled families;

WHEREAS, the **NHA** shall have the following roles and responsibilities under the Memorandum of Understanding:

- (a) **Conduct Beneficiaries Data Profiling;**
- (b) **Encourage people's organizations to strengthen their capacity to negotiate and leverage with any business entity;**
- (c) **Train community-based enterprise owner to manage their own livelihood and economic activities to ensure sustainability of projects and programs;**
- (d) **Assist beneficiaries by making referrals to microfinance institutions in the provision of additional capital for the expansion of their small scale enterprise;**
- (e) **Implement relevant skills training programs to introduce and upgrade the skills of the labor force to meet the manpower requirements of the nearby communal and industrial establishments in the area.**

While the **CGM** shall:

- (a) **Provide or link the livelihood programs through the Economic Development Cluster of Muntinlupa that are suitable to the NHA relocates;**
- (b) **Evaluate and qualify the list of participants endorsed by NHA, who will undergo various skills training based on set of requirements identified in the training regulations of any programs that they may be interested with;**
- (c) **Conduct the assessment to graduates of various training programs they completed and issue the certification to ensure their employment and absorption by labor markets.**

WHEREAS, upon review of the proposed Memorandum of Understanding based on existing and relevant laws, rules, and regulations, the **City Legal Office** interposed **no objections to the terms and conditions** thereof;
