**WHEREAS**, Section 455 (b)(1)9(vi) of the Local Government Code provides that, *the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 15 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod*”;

**WHEREAS**, Partnerships and joint ventures between public and private sectors are encouraged under the law as it will not only enhance the development of the Local Government Units but likewise foster goodwill and cooperation;

**WHEREAS**, Boysen Philippines, a corporation duly organized and existing under Philippine Laws with office address at 292 D. Tuazon St., Quezon City and represented by its Vice President for Marketing, Mr. Ruben D. Cueto, offers repainting of various infrastructures located in the City.

**WHEREAS**, Boysen shall undertake and complete the repainting works (and provide needed supplies and labor) for the following infrastructures in the City, free of charge:

- a. **Alabang Viaduct/flyover post located at Alabang Starmall, post/pillars with existing logo of Boysen.**
- b. **Alabang Flyover footbridge located under Alabang Flyover connected to the Alabang Starmall.**
- c. **Alabang Metro Mall footbridge located at Alabang Public Market.**
- d. **Alabang Metro Mall footbridge located at Alabang Viaduct.**
- e. **Susana Footbridge along National Road in front of SM Muntinlupa**
- f. **Poblacion Footbridge**
- g. **Tunasan Footbridge**
- h. **Alabang Montillano Footbridge**
- i. **Sucat Interchange along Dr. A. Santos Ave. near SLEX Sucat Muntinlupa Exit.**

**WHEREAS**, for consideration of the painting works, the following rights and obligations are thus created:

- a. Boysen is allowed to post its logo in conspicuous areas, the size of which shall be substantially smaller than the logo of the City;
- b. The City Government of Muntinlupa shall provide Boysen the needed assistance to secure the concerned areas while painting works is on-going;
- c. The City Government of Muntinlupa and Boysen Philippines, Inc., agree and undertake that the installed logos of the latter shall remain untouched and not to be replaced within a period of 3 years, unless there is a need to repaint due to damage;
- d. After the three-year period, Boysen Philippines, Inc., shall have the right, but under no obligation, for the priority for re-negotiation/renewal of contract for the necessary repainting of the footbridges and flyovers, all free of charge;
- e. Labor and materials shall be on the account of Boysen; and
- f. In case there is a need for repainting within the three-year period, Boysen shall undertake re-touching of the paint with free labor and materials;

**WHEREAS**, the **City Legal Office (CLO)** finds no legal impediment in the execution of the Memorandum of Agreement (MOA);

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon** to represent the City Government of Muntinlupa in a **Memorandum of Agreement (MOA)** with **Pacific Paint (Boysen) Philippines, Inc.**, represented by **Mr. Ruben D. Cueto, Vice President for Marketing**, on the conduct of repainting works on selected infrastructure projects located at Muntinlupa City.

**ADOPTED**, by the 10<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa**, this 27<sup>th</sup> day of **December 2022**, on its 25<sup>th</sup> **Regular Session**.
