WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991 (LGC)," provides that, "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 22(a), par. 5 of LGC states that, "(a) Every local government unit, as a corporation, shall have the following powers: Xxx (5) To enter into a contract. Xxx;"

WHEREAS, Section 22(c) of the same Code further provides that, "Unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned;"
