WHEREAS, Section 17, Article II of 1987 Philippine Constitution provides that, **“The state shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress to promote total human liberation and development”**;

WHEREAS, Republic Act 9155 otherwise known as the Governance of Basic Education Act of 2001, provides that one of its purposes and objective is, **“ to establish schools as facilities where school children are able to learn a range of core competencies prescribed for elementary and high school education program”**;

WHEREAS, DepEd Order No. 40, series of 2014 provides for the Revised Guidelines on the Establishment, Merging, Conversion, and Naming/Renaming of Public Schools, and Separation of Public Schools Annexes in Basic Education;

WHEREAS, under the same Order, requests for creation of new schools whether initiated by the Central, Regional or Division Office, or any stakeholder, must be in accordance with DepEd criteria and standards. Under DepED order No 40, The request for the establishment of the proposed Sucat Senior High School (SSHS) shall undergo evaluation by the concerned committees (Division Review and Evaluation Committee, Regional Inspectorate Team) until the Regional Director approves the same;

WHEREAS, DepEd Order No. 51, series of 2015 provides for the establishment of a stand-alone Senior High School, ***“Guidelines On The Implementation Of The SHS Program In Existing Public JHSS and ISS, Establishment Of Stand-Alone Public SHSS, and Conversion Of Existing Public Elementary And JHSS Into Stand-Alone SHSS.”***

WHEREAS, on December 1, 2022 a letter from Ms. Clarissa C. Avila, OIC of SSHS Public School District Supervisor, noted by Ms. Carleen S. Sedilla, School Division Superintendent of Muntinlupa, requested the Sangguniang Panlungsod to adopt a resolution for the creation of the **Sucat Senior High School**;

WHEREAS, Muntinlupa City has a population growth rate of 1.58% based on the 2020 census of Philippine Statistics Authority (PSA) and the said populace is composed mainly of citizens who are qualified for secondary education, hence, a need to establish more schools to decongest existing schools thereby upgrading the quality of learning and instruction in our city;

WHEREAS, the establishment of new schools is in consonance with the **7K Agenda** under **“Karunungan”** of the **Honorable City Mayor Rozzano Rufino B. Biazon**. Under said agenda, the **importance of education of as a means in achieving personal growth contributes to the country’s development**;

WHEREAS, the establishment of **Sucat Senior High School (SSHS)** located at Sucat, Muntinlupa City is the fruition of the commitment of the City Government to its constituency for its vision of **“educated people”** as embodied in the **City’s Vision**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa to request the **Hon. Atty. Jaime R. Fresnedi**, representative of the **Lone Congressional District of Muntinlupa**, to sponsor a bill in Congress for the Establishment of Sucat Senior High School With Accountancy, Business And Management (ABM) And General Academic Strand (GAS) Academic Tracks And Home Economic And Industrial Arts Strand.
