WHEREAS, Section 458 of Republic Act 7160 otherwise known as the Local Government Code (LGC), states that, "***The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to general welfare and in the proper exercise of the corporate powers of the city as provided for under section 22 of the LGC shall, approve ordinances and pass resolutions necessary for an efficient and effective city government;***"

WHEREAS, Article 86(b) (1) (vi) of the Rules and Regulations Implementing the LGC, provides that, "***for efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;***"

WHEREAS, pursuant to Republic Act 10121 otherwise known as the Philippine Risk Reduction and Management Act of 20210, the City of Muntinlupa conducts programming of its Local Disaster Risk Reduction Management Fund, other dedicated disaster risk reduction and management resources, and other regular funding source/s and budgetary support for disaster related activities;

WHEREAS, the *Muntinlupa Contingency Plans for Disasters (Flood, Earthquake and Covid-19 pandemic)* has been adopted by the Sangguniang Panlungsod through various legislative measures where the policies, course of action, resources allocation aimed to build disaster resilient communities and institutionalize arrangement and measures for reducing disaster risks are underscored;

WHEREAS, an important component of an effective **Contingency Plan** is to ensure the adequate supply and fast distribution of goods and medicines being used for relief assistance to affected constituents during and in the aftermath of a disaster;

WHEREAS, as one of the countries included in the “**ring of fire**” and most affected by climate change, the Philippine government’s stance is to be proactive in relief operations by prepositioning of relief supplies at the local level to ensure that there are supplies which can be readily and easily accessed upon the occurrence of disasters;

WHEREAS, the City of Muntinlupa, within the period of **three (3) years**, supports the Prepositioning of relief goods posed by the **Department of Social Services and Development (DSSD)** as this would contribute in the increased preparedness for disaster of the city;

WHEREAS, the **Relief Prepositioning Agreement (RPA)** includes the rights and obligations of each parties to which the City Legal Office posed its observation: *“This office has no legal objection to the MOA, subject to compliance to the guidelines set forth by the DSWD in the receipt, accountability and care and custody of prepositioned goods. During the disaster, the City is at the frontline of service delivery and thus, must always be prepared and equipped to take emergency action and relief measures. The prepositioning of food and non-food items from DSWD-NCR is a welcome augmentation to our disaster preparedness efforts;”*

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Honorable City Mayor Rozzano Rufino B. Biazon** to represent the **City Government Of Muntinlupa** in a **Relief Prepositioning Agreement (RPA)** with the **Department of Social Welfare and Development Field Office National Capital Region (DSWDFO-NCR)** represented by its **Regional Director Monina Josefina H. Romualdez**.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa**, this **29th** day **January 2023**, on its **29th** Regular Session.




