WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, **"the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160; the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod"**;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that, **"Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, Section 35 of LGC of 1991, provides that, “*Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.*”;

WHEREAS, **SAN BEDA COLLEGE ALABANG** (SBC, Alabang), a learning institution, which in the exercise of its humanitarian mandate/responsibility, promote and builds families for children by providing educational support for students, faculty and adult learners in its premises;

WHEREAS, in the implementation of social and welfare development services and values/attitudes being undertaken by SBC Alabang, the community-based training activity provided by the City Government of Muntinlupa, through its Muntinlupa City Technical Institute's (MCTI), will further the chances of candidate- beneficiaries to becoming a responsible Filipino citizen;

WHEREAS, the partnership between the City Government of Muntinlupa and SBC Alabang includes, among others, the following rights and obligations:

SBC ALABANG

1. Nomination of adult learners, student and faculty to the community-based activity;
2. Assign personnel and Training Coordinator;
3. Provide trainees with tools and materials;
4. Payment of fees mandated under Ordinance 06-096.

CITY GOVERNMENT OF MUNTINLUPA

1. Facilitate TESDA certified trainings;
2. Designate Industrial Coordinator who will undertake specific functions;
3. Conduct theoretical and practical training within its premises.

WHEREAS, the City Legal Office has reviewed the MOA and interposed no objection to the same;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Honorable City Mayor Rozzano Rufino B. Biazon** to enter and sign the **Memorandum Of Understanding (MOU)** with **San Beda College Of Alabang** on its partnership with **Muntinlupa City Technical Institute's (MCTI) Community- Based Training Activity** for the former's students, faculty, and adult learners.

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 30th day of **January 2023**, on its 30th Regular Session.
