CENTENO, HUMAN RESOURCES AND ADMINISTRATION MANAGER, ON THE PROVISION OF PRACTICAL IN-PLANT TRAINING BY THE NISSAN ALABANG FOR STUDENTS OF THE MUNTINLUPA CITY TECHNICAL INSTITUTE (MCTI)

WHEREAS, Section 455 (b)(1)(vi) of the Local Government Code provides that, **"the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod"**;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**;

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing the Local Government Code of 1991 provides that, **"Unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian."**;

WHEREAS, Section 35 of LGC of 1991, provides that, **“Local government units may enter into joint ventures and such other cooperative arrangements with people's and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.”;**

WHEREAS, the **Muntinlupa City Technical Institute (MCTI)**, is the City Government of Muntinlupa's technical and vocational institution which is mandated to implement hard or soft modular courses and non-degree trades;

WHEREAS, as part of its corporate social responsibility, Nissan Alabang, a domestic corporation duly organized and existing under and by virtue of Philippines laws with principal place of business at Southgate, Barangay Alabang, Muntinlupa City, proposed the in-plant training of the students of the MCTI;

WHEREAS, the in-plant training of MCTI students with Nissan Alabang is embodied in a Memorandum of Agreement which include among others, the following rights and obligations:

1. **Qualified students will undergo orientation under the supervision of a designated MCTI coordinator;**
2. **Admission to the training shall be based on the standards and qualifications set by Nissan Alabang;**
3. **Deployed qualified trainees to the operating units shall undergo Three Hundred Fifty (350) hours;**
4. **Injuries or accidents suffered by trainee in the course of participation in the program is not a liability of Nissan Alabang;**
5. **Compliance with the Data Privacy Act of 2012 and its implementing Rules.**

WHEREAS, the City Legal Office poses no objection to the MOA with recommendation that it should be, **“subject to compliance with pertinent TESDA guidelines and regulations and in particular, in consideration of the “new normal conditions” and a reminder for the establishment “to be carefully and thoroughly vetted and properly licensed and registered before referring our students/trainees for SIT/OJT. It must also be ensured that the student/trainees are properly briefed and oriented on OJT procedures, behavior, work ethics, etc., before they start with the training;”**

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Rozzano Rufino B. Biazon**, to enter and sign the **Memorandum Of Understanding (MOU)** with **Nissan Alabang** represented by **Maria Teresa N. Centeno**, Human Resources And Administration Manager, on the provision of **practical in-plant training** by the **Nissan Alabang** for students of the **Muntinlupa City Technical Institute (MCTI)**.
