**WHEREAS**, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the *“State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost”*;

**WHEREAS**, Republic Act 7160 otherwise known as the 1991 Local Government Code mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all Local Government Units (LGUs) at all levels;

**WHEREAS**, Section 22 of Republic Act 11223 otherwise known as the Universal Health Care (UHC) Act 2019 mandated *“the National Government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of province-wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans”*;

**WHEREAS**, RA 11223 likewise provides that, *“The DOH and the local government units (LGUs) shall endeavor to provide a health care delivery system that will afford every Filipino a primary care provider that would act as the navigator, coordinator, and initial and continuing point of contact in the health care delivery system”*;
