WHEREAS, Section 11(b)(1) of Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Plan, provides that, ***“The Local Disaster Risk Reduction and Management Council (LDRRMC) shall approve, monitor and evaluate the implementation of the Local Disaster Risk Reduction and Management Plan (LDRRMP) and regularly review and test the plan consistent with other national and local planning programs”;***

WHEREAS, RA 10121 likewise requires that every LGU should be able to establish a LDRRMP aligned with National Disaster Risk Reduction and Management Plan (NDRRMP) with themes on disaster preparedness, response, prevention and mitigation, and rehabilitation and recovery;

WHEREAS, pursuant to the mandate of the LDRRMP, it crafted the **Muntinlupa City Disaster Risk Reduction and Management Plan (MCDRRMP)** presented the same to the Sangguniang Panlungsod, which adopted it through Resolution 18-306 (Contingency Plan for Earthquake for 2018) and Resolution 18-307 (Contingency Plan for Flood);

WHEREAS, the declaration of the pandemic in 2020 refocused every disaster preparedness, response, prevention and mitigation, and rehabilitation and recovery policies to include Covid-19. Hence, Resolution 2022-669 (Contingency Plan for Earthquake for FY 2022) and Resolution 2022-670 (Contingency Plan for Flood for FY 2022) includes interim guidelines and protocols for the dreaded virus were adopted;
