**WHEREAS**, Section 2(g) of Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, provides that, it shall be the policy of the State to ***“Mainstream disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting, and governance, particularly in the areas of environment, agriculture, water, energy, health, education, poverty reduction, land-use and urban planning, and public infrastructure and housing, among others”***;

**WHEREAS**, the same statute created the Local Disaster Risk Reduction Management Council (LDRRMC) which shall, among others, ***“Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction”***;

**WHEREAS**, on 24<sup>th</sup> day of November 2022, the Local Disaster Risk Reduction and Management Council approved **LDRRMC Resolution No. 14, Series of 2022**, approving the ***Contingency Plan For Earthquake 2023-2031 Integrated Emerging And Re-Emerging Infectious Diseases Response Protocol*** based on the Muntinlupa Disaster Risk Reduction and Management Office’s gathered and consolidated local disaster risk information;

**WHEREAS**, the updated Contingency Plan for Earthquake 2023-2031 is also pursuant to the National Disaster Risk Reduction and Management Council (NDRRMC)-issued Memorandum Circular No. 57 series of 2020, ***“Reminding stakeholders on the need to remain steadfast in addressing the continuing event and in preparing for other hazards and possible worst case disaster scenarios that may occur amidst the ongoing public health emergency due to the Coronavirus Disease 2019”***;
