BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A PARTNERSHIP WITH THE DEPARTMENT OF HEALTH FOR THE LOCAL IMPLEMENTATION OF THE UNIVERSAL HEALTH ACT AND THE FOURMULA ONE PLUS FOR HEALTH PROGRAM, APPROVING HERETO THE 2022 ANNUAL OPERATIONAL PLAN (AOP) OF THE CITY OF MUNTINLUPA

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavour to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, Republic Act 7160 otherwise known as the 1991 Local Government Code mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all Local Government Units (LGUs) at all levels;

WHEREAS, Section 22 of Republic Act 11223 otherwise known as the Universal Health Care (UHC) Act 2019 mandated the National Government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of province-wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans;

WHEREAS, RA 11223 likewise provides that, The Department of Health (DOH) and the local government units (LGUs) shall endeavor to provide a health care delivery system that will afford every Filipino a primary care provider that would act as the navigator, coordinator, and initial and continuing point of contact in the health care delivery system;

WHEREAS, the DOH is mandated under RA 11223, "To create a framework that fosters a whole-of-system, whole-of-government, and whole-of-society approach in the development, implementation, monitoring, and evaluation of health policies, programs and plans", thus the Fourmula One Plus for Health was established;

WHEREAS, Fourmula One Plus for Health emphasizes four sets of instruments that must be applied in order to decentralize public health care system and local health care market. The thrusts of the program are : health financing, health regulation, health service delivery and good governance;

WHEREAS, the Local Investment Plan for Health (LIPH) is the key instrument in forging the Department of Health (DOH) and Local Government Unit (LGU) partnership to carry out the Fourmula One Plus for Health, and technical assistance from the DOH shall be consolidated and matched with the needs outlined in the Local Investment Plans for Health and the implementation of the LIPH is translated through the Annual Operation Plans;

WHEREAS, in preparation to be part of the aforesaid programs, the City of Muntinlupa, through its City Health Office, has prepared its 2020-2022 LIPH, and 2022 AOP;

WHEREAS, the CITY shall receive an estimated allocation of FORTY SIX MILLION THREE HUNDRED THIRTY-ONE THOUSAND TWO HUNDRED SEVENTY FIVE PESOS AND 28/100 (Php46,331,275.28) support (financial and non-financial grants) from the National Government-DOH for the implementation of the approved 2022 AOP;

WHEREAS, the implementation of the approved 2022 AOP shall be funded by various sources which may include the following: 1) Local Government Unit Funds, 2) Fund transfers from the DOH-CHD, 3) Support in kind or commodities from the DOH regular budget of the Central Office, coursed through the DOH-CHD, 4) PhilHealth payments, and 5) Other funds identified by DOH-CHD and LGU, including funds from development partners, and other stakeholders;

WHEREAS, resources from DOH and LGU to support implementation of the approved 2022 AOP will be distributed as follows:


