A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO A CONSTRUCTION AGREEMENT WITH ST. TIMOTHY CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF MALASAKIT CENTER EXTENSION RAMP AND WAITING AREA LOCATED AT OSPITAL NG MUNTINLUPA (OSMUN), FILINVEST CORPORATE CITY, BARANGAY ALABANG, MUNTINLUPA CITY, IN THE AMOUNT OF TWO MILLION FIFTY-FIVE THOUSAND TWO HUNDRED FIFTY-FOUR PESOS (PHP2,055,254.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF) AND INFRA FUND

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**Xxx Authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, "**The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, the authority given by the **Sangguniang Panlungsod** to the **City Mayor Rozzano Rufino B. Biazon** to enter into a Construction Agreement is based on the evaluation of documents submitted by the Bids and Awards Committee (BAC);

WHEREAS, the City Government of Muntinlupa advertised the invitation to apply for eligibility and to bid for the project **Malasakit Center Extension Ramp and Waiting Area at Ospital ng Muntinlupa (Osmun), Filinvest Corporate City, Barangay Alabang, Muntinlupa City**, likewise posted at the Philippine Government Electronic Procurement System (PhilGEPS) and City's Website and the same conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisement, one (1) bidder submitted letter of intent and application for eligibility and was found eligible on **November 22, 2022**;

WHEREAS, one (1) Bidder who submitted their Bid on **November 22, 2022** and bidder passed the Preliminary Examination of Bid at the City Administration Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements submitted by the bidder with lowest calculated bid, **St. Timothy Construction Corporation's** bid has been responsive to **Approved Budget for the Contract (ABC)** amounting to **Two Million Eighty Thousand Two Hundred Thirty-Six Pesos and 50/100 (Php2,080,236.50)**;

WHEREAS, the project was awarded to **St. Timothy Construction Corporation**, being the lowest bidder for the project **Malasakit Center Extension Ramp and Waiting Area** located at Ospital ng Muntinlupa (Osmun), Filinvest Corporate City, Barangay Alabang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon**, in behalf of the City Government of Muntinlupa to enter into a **Construction Agreement (CA)** with **St. Timothy Construction Corporation** for the project construction of **Malasakit Center Extension Ramp and Waiting Area** at Ospital ng Muntinlupa (Osmun), Filinvest Corporate City, Barangay Alabang, Muntinlupa City in the amount of **Two Million Fifty-Five Thousand Two Hundred Fifty-Four Pesos (Php2,055,254.00)** which amount shall be taken from the **2022 Executive Budget** under 20% Community Development Fund (CDF) and Infra Fund.
