WHEREAS, the **Philippine Councilors League (PCL)** is a nationwide organization of more than 17,000 councilors spread in all provinces, cities and municipalities, including the **National Capital Region (NCR)**, the **Cordillera Administrative Region (CAR)** and the **Bangsamoro Autonomous Region for Muslim Mindanao (BARMM)**;

WHEREAS, the PCL is a recognized organization supervised by the **Department of Interior and Local Government (DILG)** pursuant to Section 508 of R.A. 7160, otherwise known as the New Local Government Code of 1991 and is a member of the **Union of Local Authorities of the Philippines (ULAP)**;

WHEREAS, the PCL conducts its elections at the national, island, regional, provincial federation and city chapter levels every three years following the assumption into office of the duly elected local officials in the local elections also held every three years;

WHEREAS, the Office of the National Chairman is the highest position in the league as provided for under the PCL Constitution and By Laws and he is the presiding officer of the National Board, the policy-making body composed of the elected Regional Chairpersons of every region in the country;

WHEREAS, Hon. Coun. Atty. Raul R. Corro was endorsed as the next National Chairman by the former officers of the league led by outgoing **President Jose Nelson Tata Sala**, former **President Luis Chavit Singson**, former **President Luis Bustamante** and former National Chairmen **Alan Zulueta** and **Danny Dayanghirang** as well as the **Metro Manila Councilors League (MMCL)**, the **PCL Advocacy Group** and **PCL Alumni, Provincial and City Presidents** and many other concerned councilors, recognizing his long experience and expertise as a local legislator for seven elected terms and his track record of service in the PCL as Chairman of the Advocacy Committee and Regional Chairman of the National Capital Region; Whereas, as Chairman of PCL Advocacy, Coun. Corro is credited by the PCL National Board and the National Executive Officers for the approval of the law granting professional eligibility to sanggunian members who are college graduates and who have completed three elected terms in office without taking the Civil Service examinations;




