**WHEREAS, Section 2 of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, provides that, "It is the declared policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions, and instrumentalities, including government-owned and/or -controlled corporations, and local government units";**

**WHEREAS, Section 3 of the 2016 Rules and Regulations Implementing RA 9184 states that, "The procurement of the Government of the Philippines shall be governed by the principle of transparency in the procurement process and in the implementation of procurement contracts through wide dissemination of bid opportunities and participation of pertinent non-government organizations," among others;**

**WHEREAS, Section 7, supra, provides, "All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP)";**

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, **"The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, the Contract of Service was signed by both parties and duly notarized on January 30, 2023;

WHEREAS, the City Government of Muntinlupa, in its approved **Annual Procurement Plan (APP)**, listed the Services: **Arterial Blood Gas Reagent** of the **Ospital ng Muntinlupa** located at the **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City**;

WHEREAS, the duly constituted **Bids and Awards Committee (BAC)** of Muntinlupa, acting on its mandate, advertised the invitation to apply for eligibility and to bid for the project: **Arterial Blood Gas Reagent Tie Up at the Ospital ng Muntinlupa** located at the **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City**. To comply with the provisions of Procurement Act and its IRR, and R.A. 8792, otherwise known as the "Electronic Commerce Act, the same project was likewise posted continuously for seven (7) days at the **Philippine Government Electronic Procurement System (PhilGEPS)**, City's website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication/s, lone bidder submitted its/ their letter/s of intent and application/s for eligibility:

WHEREAS, on **December 28, 2022**, **Biosite Medical Instruments**, submitted its bid documents. In the Preliminary Examination of Bid conducted at the City Administrator's Conference Room, 2<sup>nd</sup> Floor City Hall Main Building, it was determined that the required bid documents were present and may be considered for opening and evaluation of their financial component;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements, **Biosite Medical Instruments's**, bid was adjudged to be responsive to the Approved Budget for the Contract (ABC) amounting to Two Million Three Hundred Thousand Pesos (Php2,300,000.00). Thereafter, the project/service was awarded to **Biosite Medical Instruments** as the Highest Rated Responsive bidder for the provision of **Arterial Blood Gas Reagent** of the **Ospital ng Muntinlupa** located at the **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City**;
