A RESOLUTION RATIFYING THE CONTRACT OF SERVICE ENTERED AND SIGNED BY THE HON. CITY MAYOR ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH JOINT VENTURE OF STERI PLUS CORPORATION & ECON SAFE HAZMAT TREATMENT INC., FOR THE SERVICES OF COLLECTION, TREATMENT AND DISPOSAL OF VARIOUS HOSPITAL WASTE OF OSPITAL NG MUNTINLUPA LOCATED AT THE CIVIC DRIVE, FILINVEST CORPORATE CITY, BARANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO THREE MILLION SIX HUNDRED THOUSAND PESOS (P3,600,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2023 EXECUTIVE BUDGET

WHEREAS, Section 3 of the 2016 Rules and Regulations Implementing RA 9184 states that, **"The procurement of the Government of the Philippines shall be governed by the principle of transparency in the procurement process and in the implementation of procurement contracts through wide dissemination of bid opportunities and participation of pertinent non-government organizations,"** among others;

WHEREAS, Section 7, supra, provides, **“All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP)”**;

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, **“The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”**;

WHEREAS, the Contract of Service was signed by both parties and duly notarized on **January 30, 2023**;

WHEREAS, the City Government of Muntinlupa, in its approved **Annual Procurement Plan (APP)**, listed the Services: **Collection, Treatment and Disposal Of Various Hospital Waste** at the **Ospital ng Muntinlupa** located at the **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City**;

WHEREAS, the duly constituted **Bids and Awards Committee (BAC)** of Muntinlupa, acting on its mandate, advertised the invitation to apply for eligibility and to bid for the project/service: **Collection, Treatment and Disposal Of Various Hospital Waste at the Ospital ng Muntinlupa** located in **Civic Drive, Filinvest Corporate City, Barangay Alabang, Muntinlupa City**. To comply with the provisions of Procurement Act and its IRR, and R.A. 8792, otherwise known as the “Electronic Commerce Act, the same project was likewise posted continuously for seven (7) days at the **Philippine Government Electronic Procurement System (PhilGEPS)**, City’s website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication/s, lone bidder submitted its/ their letter/s of intent and application/s for eligibility:

In the Preliminary Examination of Bid conducted at the City Administrator’s Conference Room, 2nd Floor City Hall Main Building, it was determined that the required bid documents were present and may be considered for opening and evaluation of their financial component;
