A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO AN AMENDED MEMORANDUM OF AGREEMENT (MOA) WITH EUROLINK NETWORK INTERNATIONAL CORPORATION, REPRESENTED BY ITS AVP FOR FINANCE, ABIGAIL ONG, ON THE LATTER'S ENGAGEMENT AS HEALTH INFORMATION TECHNOLOGY PROVIDER (HITP) OF THE CITY OF MUNTINLUPA FOR ITS OUTPATIENT HIV/AIDS TREATMENT PACKAGE (OHAPT) ECLAIMS AS PROVIDED BY PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **"Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"**;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-RR), provides that. **"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance."**;

WHEREAS, on November 28, 2022, the Sangguniang Panlungsod adopted Resolution No. 2022-143 granting authority to the **City Mayor Hon. Rozzano Rufino B. Biazon** in behalf of the City Government of Muntinlupa to enter into a **Memorandum Of Agreement (MOA)** with **Eurolink Network International Corporation**, represented by its **AVP For Finance, Abigail Ong**, on the latter's engagement as Health Information Technology Provider (HITP) of the City Of Muntinlupa for its Outpatient HIV/AIDS Treatment Package (OHAPT) eClaims as provided by Philippine Health Insurance Corporation (PHILHEALTH);

WHEREAS, in the MOA covered by Resolution 2022-143, the provision on the Pre-termination Clause is nil. The amended MOA proposed the following provision:

"Should the Client (City Government Of Muntinlupa) intend to pre-terminate this Agreement for whatever cause, the Client shall notify Eurolink in writing at least Thirty (30) calendar days in advance of the pre-termination date, and shall, simultaneously pay therewith, to Eurolink a pre-termination fee in the amount of Fifty Thousand Pesos (Php50,000.00)"

WHEREAS, the City Legal Office opined in its 11 January 2023 letter, ***"On the amendment to the pre-termination clause, we propose that the pre-termination fee whichever is lower between the Php50,000.00 or the monthly average claims for the remaining contract duration;"***

WHEREAS, the opinion of the CLO is most beneficial and advantageous to the City Government;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** in behalf of the **City Government Of Muntinlupa** to enter into an amended **Memorandum Of Agreement (MOA)** with **Eurolink Network International Corporation**, represented by its **AVP For Finance, Abigail Ong**, on the latter's engagement as **Health Information Technology Provider (HITP)** of the City Of Muntinlupa for its Outpatient HIV/AIDS Treatment Package (OHAPT) eClaims as provided by Philippine Health Insurance Corporation (PHILHEALTH).

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 6th day of February 2023, on its 31st Regular Session.






