A RESOLUTION RATIFYING THE CONTRACT OF SECURITY SERVICES ENTERED AND SIGNED BY THE HON. CITY MAYOR ROZZANO RUFINO B. BIAZON IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH JOINT VENTURE OF BEST SECURITY AGENCY, INC. AND BEST ARMS SECURITY REPRESENTED BY ROBERTO LANTING AND ALVIN RIBERTA, RESPECTIVELY, FOR THE PROVISION OF SECURITY AND PROTECTION SERVICES AT VARIOUS GOVERNMENT SITES (CITY HALL, MUNTINLUPA SPORTS COMPLEX, DEPARTMENT OF RISK REDUCTION AND MANAGEMENT, OSPITAL NG MUNTINLUPA, MUNTINLUPA PUBLIC MARKET, PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMUN) COLEGIO DE MUNTINLUPA AND PACWOOD) ALL LOCATED AT THE CITY OF MUNTINLUPA AMOUNTING TO SIXTY-ONE MILLION NINE HUNDRED SIXTY-NINE THOUSAND FIVE HUNDRED EIGHTY-TWO PESOS AND 82/100 (PHP61,969,582.82) WHICH AMOUNT SHALL BE TAKEN FROM THE 2023 EXECUTIVE BUDGET

WHEREAS, Section 2 of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, provides that, ***"It is the declared policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions, and instrumentalities, including government-owned and/or -controlled corporations, and local government units"***;

WHEREAS, Section 3 of the 2016 Rules and Regulations Implementing RA 9184 states that, ***"The procurement of the Government of the Philippines shall be governed by the principle of transparency in the procurement process and in the implementation of procurement contracts through wide dissemination of bid opportunities and participation of pertinent non-government organizations,"*** among others;

WHEREAS, Section 7, supra, provides that, **"All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity. Consistent with government fiscal discipline measures, only those considered crucial to the efficient discharge of governmental functions shall be included in the Annual Procurement Plan (APP)";**

WHEREAS, Article 86 (b) (1) (vi) of the Implementing Rules and Regulations (IRR) of Local Government Code of 1991, provides that, **"The City Mayor shall represent the city in all its business transactions and sign in its behalf all bond, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";**

WHEREAS, the Security and Protection Services were signed by both parties and duly notarized on **January 30, 2023;**

WHEREAS, the City Government of Muntinlupa, in its approved **Annual Procurement Plan (APP)**, listed the Services: **security and protection services** at the premises of **City Hall, Sports Complex, Department of Risk Reduction and Management, Ospital Ng Muntinlupa, Public Market, Pamantasan ng Lungsod ng Muntinlupa (PLMun) Colegio De Muntinlupa and Pacwood** all located at the City of Muntinlupa;

WHEREAS, the duly constituted **Bids and Awards Committee (BAC)** of Muntinlupa, acting on its mandate, advertised the invitation to apply for eligibility and to bid for the project: **Security And Protection Services** at the premises of **City Hall, Muntinlupa Sports Complex, Department of Risk Reduction and Management, Ospital Ng Muntinlupa, Muntinlupa Public Market, Pamantasan ng Lungsod ng Muntinlupa (PLMun) Colegio De Muntinlupa and Pacwood** all located at the City of Muntinlupa. To comply with the provisions of Procurement Act and its IRR, and R.A. 8792, otherwise known as the "Electronic Commerce Act, the same project was likewise posted continuously for seven (7) days at the **Philippine Government Electronic Procurement System (PhilGEPS)**, City's website and conspicuous places within the premises of the City Government of Muntinlupa;

WHEREAS, in response to the said advertisement/s and publication/s, lone bidder submitted its/their letter/s of intent and application/s for eligibility:

WHEREAS, on **December 28, 2022**, **Joint Venture of Best Security Agency and Best Arms Security**, submitted its bid documents. In the Preliminary Examination of Bid conducted at the City Administrator's Conference Room, 2nd Floor City Hall Main Building, it was determined that the required bid documents were present and may be considered for opening and evaluation of their financial component;

WHEREAS, after careful examination, validation and verification of all the eligibility, technology and financial requirements, Joint Venture of Best Security Agency and Best Arms Security's bid was adjudged to be responsive to the **Approved Budget for the Contract (ABC)** amounting to **Sixty-Three Million Sixty-Two Thousand Eighty-One Pesos and 76/100 (Php63,062,081.76)**. Thereafter, the project/service was awarded to **Joint Venture of Best Security Agency and Best Arms Security**, for the provision of security and protection services at the premises of **City Hall, Muntinlupa Sports Complex, Department of Risk Reduction and Management, Ospital Ng Muntinlupa, Muntinlupa Public Market, Pamantasan ng Lungsod ng Muntinlupa (PLMun) Colegio De Muntinlupa and Pacwood** all at the City of Muntinlupa;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 10th Sangguniang Panlungsod, to ratify the Contract of Security Services entered and signed by the **Hon. City Mayor Rozzano Rufino B. Biazon** in behalf of the City Government Of Muntinlupa with **Best Security Agency, Inc.** and **Best Arms Security** represented **Alvin Riberta** and **Mr. Roberto Lanting** respectively, for the security and protection services at various City Government Sites (**City Hall, Sports Complex, Department of Risk Reduction and Management, Ospital Ng Muntinlupa, Public Market, Pamantasan ng Lungsod ng Muntinlupa (PLMun) Colegio De Muntinlupa and Pacwood**) amounting to **Sixty-One Million Nine Hundred Sixty-Nine Thousand Five Hundred Eighty-Two Pesos and 82/100 (Php61,969,582.82)** which amount shall be taken from the **2023 Executive Budget**.
