A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ATTY. JAIME R. FRESNEDI TO SIGN AND ENTER INTO, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA, A LETTER OF AGREEMENT WITH THE ASIAN DEVELOPMENT BANK (ADB), THE PHILIPPINE GOVERNMENT AND THE MUNTINLUPA DEVELOPMENT FOUNDATION (MDF) ON THE JAPAN FUND FOR POVERTY REDUCTION (JFPR) ASSISTANCE FOR SUPPORTING THE OFF-SITE AND OFF-CITY RELOCATION OF VULNERABLE SLUM COMMUNITIES OF MUNTINLUPA CITY PROJECT.

WHEREAS, Section 17 (a) and (b) (3) (viii) of the Local Government Code of 1991, states that:

- (a) Local government units shall endeavor to be self-reliant and should continue exercising the powers and discharging the duties and functions currently vested upon them
- (b) Such basic services and facilities include but not limited to the following:
 - (viii) Programs and projects for low-cost housing and other mass dwellings.

WHEREAS, Section 35 of the Local Government Code states that "Local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services designedto enhance the economic and social well-being of the people;

WHEREAS, Likewise, Section 455 (vi) of Republic Act 7160 provides that: "The city mayor, as the chief executive of the city government shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance";

WHEREAS, the Asian Development Bank (ADB) has strongly recommended the City Government of Muntinlupa, through Mayor Jaime R. Fresnedi, as one of the signatories on the Letter of Agreement from the Asian Development Bank (ADB) with the Philippine Government, the City Government of Muntinlupa and the Muntinlupa Development Foundation on the Japan Fund for Poverty Reduction (JFPR) assisted-Project;

WHEREAS, the inclusion of the City of Government of Muntinlupa is in recognition to the *contribution and its support to socialized housing efforts*;

WHEREAS, the City Government of Muntinlupa shall provide counterpart funding in the amount of *Ten Million Pesos (P10,000,000)* to bridge in part the cost of land purchase, site development and as a contribution to the revolving housing construction fund;

WHEREAS, under said agreement, the Muntinlupa Development Foundation (MDF), with the support of the Ayala Foundation, Inc. (AF) and the Philippine Business for Social Progress (PBSP) shall *serve as the Implementing Agency*;

WHEREAS, the realization of JFPR project would somehow *lessen* the number of informal settlers and homeless constituents, whose total population is 34, 705 families, as of the latest census, within the City of Muntinlupa;

WHEREAS, the counterpart funding shall be taken starting from the *Executive Budget for the year 2002*;

WHEREAS, any amendment/s in the terms and conditions of said agreement, made after the approval of this Resolution *shall be subject to the approval* of the Sangguniang Panlungsod;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to *authorize* the City Mayor, Hon. Jaime R. Fresnedi *to sign and enter into*, for and in behalf of the City Government of Muntinlupa, a *Letter of Agreement* with Asian Development Bank (ADB), the Philippine Government and the Muntinlupa Development Foundation (MDF) on the Japan Fund for Poverty Reduction (JFPR) Assistance for Supporting the Off-Site and Off-City Relocation of Vulnerable Slum Communities of Muntinlupa City Project.




