**WHEREAS,** the urban Strategy supports the partnership approach, the *City Development Strategy (CDS)* which calls for broad coalitions of local stakeholders and development partners, both local and international, to work together to develop strategy for a particular city/urban area;

**WHEREAS,** *City Development Strategy (CDS)* will formulate national urban strategies, scale up programs of services for the poor, enhance assistance for capability building of local governments and the local stakeholders;

**WHEREAS,** CDS, is both a planning process and a product which promotes partnership among the various stakeholders in a city – the city government, the private sector, civil society, academe and national government agencies;

**WHEREAS,** CDS objectives aim to guide the city's direction from economic development with the purpose of creating more employment opportunities, develop a consensus building process to establish the city's priorities, strategies and actions;

**WHEREAS,** CDS enables to assist Local Authorities outline their financing and investment strategies and to build local capacity for more effective urban management;

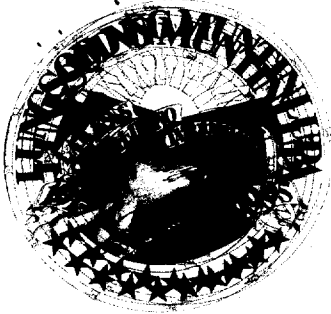
