WHEREAS, the City Government has been leasing the Doña Zoila Building, National Road, Putatan, Muntinlupa City, for the use of the City Prosecutors' Office, with the CTLG Enterprises;

WHEREAS, the Contract of Lease is renewed/extended for another two (2) years from January 1, 2001 to December 31, 2002;

WHEREAS, the lessor requested from the City Mayor to increase the monthly rental from Fifty Thousand Pesos (P50,000.00) to Sixty Thousand Pesos (P60,000.00), to be paid every 20th day of every month starting January 20, 2001;

WHEREAS, the budget allocated in the Executive Budget for the rental is only Fifty Thousand Pesos (P50,000.00) from January 2001 to December 2001;

WHEREAS, the rental of Fifty Thousand Pesos (P50,000.00) from January to December 2001 shall remain and the monthly rental of Sixty Thousand Pesos (P60,000.00) shall begin in January 2002 until December 31, 2002.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to authorize Mayor Jaime R. Fresnedi to *enter into a Contract of Lease* with the CTLG Enterprises for the lease of Doña zoila Building being used by the City Prosecutor's' Office.
