WHEREAS, Sec. 15, Art. II, "State Policies" of the 1987 Constitution of the Philippines states that, *"The State shall protect and promote the right to health of the people and instill health consciousness among them....."*;

WHEREAS, Sec. 16, General Welfare, Chapter 2, Title One, Book I of the RA 7160, otherwise known as the Local Government Code of 1991 states that, *"Local Government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety....."*;

WHEREAS, Sec. 458, "Powers, Duties, Functions and Compensations" of the Local Government Code of 1991 states that, *"The Sangguniang Panlungsod, as the legislative of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code;*

WHEREAS, pursuant to Section 458 (v) of the Local Government Code of 1991, the Sanggunian Panlungsod *shall enact ordinances intended to prevent, suppress and impose appropriate penalties for habitual drunkenness in public places"*;

WHEREAS, it is the power of the Sangguniang Panlungsod under the same Section 458 *to regulate such other events or activities for amusement or entertainment, particularly those which tend to disturb the community or annoy the inhabitants; or require the suspension or suppression of the same; or prohibit certain forms of amusement or entertainment in order to protect the social and moral welfare of the community;*

WHEREAS, Health promotion is one among priority programs included in the 8-point Program of the City of Muntinlupa;

WHEREAS, there is an ongoing National SMB Drinking Contest entitled, "Sinong Mabilis sa Beer", being done at the different barangay in coordination with barangay officials and employees;

WHEREAS, to win the contest, the team of five (5) members (including one female) has to consume their bottle of beer the fastest possible time at the least spillage for them to become the "Barangay representative" thereby giving the impression of the official nature of the activity;

WHEREAS, there are allocated barangay prizes, c/o "Barangay Captain", in the form of renovation or any barangay project, increasing in each level of competition;

WHEREAS, the competition is being done in an increasing level (with in barangay, inter-barangay, district, city, regional area, national) with the corresponding increase cash prizes plus number of cases of beer;

WHEREAS, in the process of subjecting the participants to individual time trial, practicing and actual series of competitions, the participants tend to drink more frequent and more volumes of beer to have more chances of winning, thereby exposing themselves to greater risk of alcohol abuse, liver cirrhosis and liver cancer, among others;

WHEREAS, the nature (mechanics) and scope (National) of competition somehow encourage and enhance the culture of alcoholism among Filipinos, thereby contributing to the ever increasing of Psycho-social problems brought about by alcohol abuse;

WHEREAS, it is our political, social, moral, ethical and spiritual responsibility to protect, promote and maintain good health among our constituencies;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that this resolution *be passed* expressing *strong opposition* to the ongoing National SMB Drinking Contest in Muntinlupa entitled, "Sino ang Mabilis sa Beer";

RESOLVED FURTHER, that all Barangay Chairmen be requested to inhibit themselves and spare the barangay from further participation of the said contest;

RESOLVED FINALLY, that a copy of this resolution *be furnished* to the different agencies such as DILG, DOH, DTI AND BFAD, San Miguel Brewery Corporation and Barangay Chairmen of Muntinlupa.






