A RESOLUTION REQUESTING CONGRESS TO INVESTIGATE THE STRUCTURAL WORTHINESS OF ALABANG VIADUCT FLY-OVER, LOCATED AT ALABANG, MUNTINLUPA CITY AND TO COMPEL THE PHILIPPINE NATIONAL CONSTRUCTION CORPORATION (PNCC) FOR THE IMMEDIATE REPAIR OF THE SAME.

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that "xxxxxxx Within their respective territorial jurisdictions, local government units shall ensure and support among other things, promote xxx safety, enhance economic prosperity, maintain peace and order, and preserve the comfort and convenience of the inhabitants;

WHEREAS, the Alabang Viaduct fly-over plays an important part in maintaining the normal flow of traffic of both south and Manila bound vehicles;

WHEREAS, that the Alabang Viaduct fly-over has been inoperative or impassable for heavy trucks passage for almost 5 years now, thus, giving impressions that the same is unsafe;

WHEREAS, both lanes of Alabang Viaduct, which could only accommodate light vehicles of limited volume have been utilized as an alternate entrance and exit route for heavy trucks, thus causing heavy traffic and congestion within the area;

WHEREAS, the traffic problem within the area has caused severe economic damage and losses to the City;

WHEREAS, the City Government of Muntinlupa has exhausted its administrative remedy through series of dialogues, public hearings and letter of invitation with the officials of the Philippine National Construction Corporation (PNCC), but the same was continuously disregarded by said office;

WHEREAS, the City Government of Muntinlupa was constrained to seek the assistance of Congress to preserve the comfort and safety of our constituents against the impending collapse of the fly-over and to compel PNCC for the immediate repair of the same;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod of Muntinlupa the passage of a resolution requesting Congress to investigate the structural worthiness of Alabang Viaduct Fly-over, located at Alabang, Muntinlupa City and to compel the Philippine National Construction Corporation (PNCC) for the immediate repair of the same.

RESOLVED FURTHER, that copy of this Resolution be forwarded to the Office of the Speaker of the House, the Office of the Senate President, the Office of the President of the Philippines and the Office of Representative of the Lone District of Muntinlupa.
