A RESOLUTION AUTHORIZING HONORABLE MAYOR JAIME R. FRESNEDI TO SIGN THE SUPPLEMENTAL AGREEMENT REGARDING THE VARIATION ORDER AMOUNTING TO TWO MILLION FIVE HUNDRED FOUR THOUSAND THREE HUNDRED TWENTY FOUR PESOS AND FIFTY SEVEN CENTAVOS (P 2, 504, 324.57) FOR THE IMMEDIATE UPGRADING OF THE ELECTRICAL INSTALLATION REQUIREMENTS OF THE OSPITAL NG MUNTINLUPA.

WHEREAS, Section 455 (b) (1) (vi) of Republic Act 7160 otherwise known as The Local Government Code of 1991 states that, "for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the city mayor shall:

(1) Exercise general supervision and control over all programs, projects, services, and activities of the city government, and in this connection, shall:

(vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, there is a need to upgrade the electrical installation requirements of the Ospital ng Muntinlupa in order to ensure the safety of the employees, patients and the properties at the said hospital;

WHEREAS, the immediate upgrading of the electrical installation requirements of the Ospital ng Muntinlupa would bring a better, faster and efficient delivery of basic medical services;

WHEREAS, the improvement of the electrical installation requirements of the Ospital ng Muntinlupa is part of the infrastructure development and project of the City Government;

WHEREAS, the said upgrading of the electrical installations is vital for the operations of the Ospital ng Muntinlupa to meet the electrical requirements of the medical equipment and redesigning of the area;

WHEREAS, there is an available budget for the upgrading of the electrical installation requirements of the Ospital ng Muntinlupa;

WHEREAS, COA Circular No. 91368 states that "a change order (variation order) may be issued by the implementing official after the same has been approved by the appropriate official if the amount of the change order is within the limits of the former's authority to approve original contract where the aggregate cost of the change order is limited to twenty five percent (25%) of the original contract cost";

WHEREAS, the cost of the variation order for the upgrading of the electrical installation requirements of the Ospital ng Muntinlupa is Two Million Five Hundred Four Thousand Three Hundred Twenty Four Pesos and Fifty Centavos (P2,504,324.57) which amount shall be taken from the allocation of the construction of the Ospital ng Muntinlupa contained in the Executive Budget;

NOW, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that **HON. MAYOR JAIME R. FRESNEDI** be authorized to sign a supplemental agreement regarding the variation order in the amount of Two Million Five Hundred Four Thousand Three Hundred Twenty Four Pesos and Fifty Centavos (P2,504,324.57) for the immediate upgrading of the electrical installation requirements of the Ospital ng Muntinlupa.
