WHEREAS, the term of office of the official representative to the Executive Board of the said League ends with the term of office of an elected Councilor;

WHEREAS, there is a need to re-appoint **Hon. Atty. Raul R. Corro** as official representative of Sangguniang Panlungsod to the PCL and the Metro Manila Councilors' League;

WHEREAS, it is the collective opinion of the Council that **Hon. Councilor Atty. Raul R. Corro** can ably represent the Council in the League due to his experience and track record as a local official for the last thirteen years (13), having served in various capacities as *Technical Assistant to the Mayor, Municipal Secretary, City Attorney, Public Information Officer and now a City Councilor and Assistant Majority Floor Leader* of the Sangguniang Panlungsod of Muntinlupa;

WHEREAS, as official representative of the Council to the League during the last term (July 1, 1998 up to June 30, 2001), **Councilor Atty. Raul R. Corro** was elected *Director of Metro Manila of the said League* and was also appointed *Legal Counsel of the Philippine Councilors' League, National Capital Region* and *Chairman of the Awards Committee* in the PCL National Congress held last February 19, 1999 at the Philippine International Convention Center;
