(vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the City Government of Muntinlupa is dedicated to enhance the lives of senior citizens among its constituents through its Office of the Senior Citizens Affairs (OSCA);

WHEREAS, the Senior Citizens of Muntinlupa City are given preferential attention and priority to enjoy this additional grant of incentive as an expression of gratitude to their invaluable contribution to the progress and prosperity of Muntinlupa City;

WHEREAS, the operator of the Cinemas at the Alabang Town Center have agreed to grant a seventy five percent (75%) discount inclusive of the twenty percent (20%) discount as mandated by Republic Act 7432 on the movie fees of senior citizens of the OSCA;

FRESNEDI** is authorized to enter for and behalf of the City Government of Muntinlupa into a Memorandum of Agreement (MOA) with the operator of the Alabang Town Center Cinema houses for the granting of free movies from Monday to Thursday to beneficiaries of the Office of Senior Citizens Affairs (OSCA) of Muntinlupa City.




