FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT THE DEED OF SALE TO PURCHASE A PARCEL OF LAND WITH AN AREA OF 98.13 SQUARE METERS, COVERED BY TRANSFER CERTIFICATE TITLE NO. 209108 IN THE AMOUNT OF THREE THOUSAND PESOS (P 3,000.00) PER SQUARE METER OR A TOTAL OF TWO HUNDRED NINETY FOUR THOUSAND THREE HUNDRED NINETY PESOS (P 294,390.00), LOCATED AT LOT 726-C ILAYA ST., ALABANG MUNTINLUPA CITY, TO SERVE AS RIGHT OF WAY OF THE RESIDENTS OF PRK.7-B ALABANG.

WHEREAS, The City Government, through the Office of the Mayor, negotiated to purchase the property for Three Thousand Pesos (P 3,000.00) per square meter only and the heirs of the owners thereof agreed;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to authorize Mayor Jaime R. Fresnedi to sign for and in behalf of the City Government the *Deed of Sale to purchase a parcel of land*, with an area of 98.13 square meters, covered by TCT NO. 209108 in the amount of Three Thousand Pesos (P 3,000.00) per square meter or a total of Two Hundred Ninety Four Thousand Three Hundred Ninety Pesos (P 294,390.00) located at Lot 26-C Ilaya St. Alabang, Muntinlupa City, to be used as *right of way* of the residents of Purok 7-B Alabang, Muntinlupa City.
