A STATE OF EMERGENCY DUE TO THE PRESENCE OF UNCOLLECTED
GARBAGE.**

WHEREAS, the Payatas Dumpsite in Quezon City was closed due to trash slides which caused the death of more than 200 persons;

WHEREAS, the San Mateo Landfill, the only sanitary landfill that receives the solid waste of entire Metro Manila was closed starting year 2001, due to the protest of the residents of San Mateo;

WHEREAS, the Metro Manila Development Authority has built two (2) big material Recovery Facilities in Las Piñas City and Pasig City but these two (2) could only accommodate limited truck trips per city;

WHEREAS, the Metro Manila Development Authority up to now has not identified and established a sanitary landfill to accommodate the solid waste of Metro Manila;

WHEREAS, for the past two (2) weeks solid waste all over Metro Manila, including Muntinlupa City has not been properly and promptly collected, thus leaving piles of garbage along the streets;

WHEREAS, due to the above situation, the Metro Manila Development Authority declared Metro Manila under a State of Emergency;

WHEREAS, declaring state of emergency in Muntinlupa City, the local government, both the City and Barangay could avail the calamity fund to be used for solid waste management projects and programs;
