WHEREAS, the City Government was granted a *Two Hundred Million Pesos (P200,000,000.00) Loan* for the construction and purchase of equipment of the *Ospital ng Muntinlupa* by the *Land Bank of the Philippines*;

WHEREAS, the City Government was informed by the Land Bank of the Philippines that, of this *Two Hundred Million Pesos (P200,000,000.00) loan*, *Thirty Two Million and Five Hundred Thousand Pesos (P32,500,000.00)* will come from the *Japan Bank for International Cooperation (JBIC)*;

WHEREAS, as the *Thirty Two Million Five Hundred Thousand Pesos (P32,500,000.00)* will come from the JBIC, a *Subsidiary Loan Agreement* is necessary to be executed between the City Government and the Land Bank of the Philippines;

WHEREAS, the **Land Bank of the Philippines** sent a copy of the **Subsidiary Loan Agreement** to the City Mayor for his signature, which is hereto attached to form part of this Resolution;

RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to *authorize Mayor Jaime R. Fresnedi* to sign for and behalf of the City Government the *Subsidiary Loan Agreement with the Land Bank of the Philippines*.

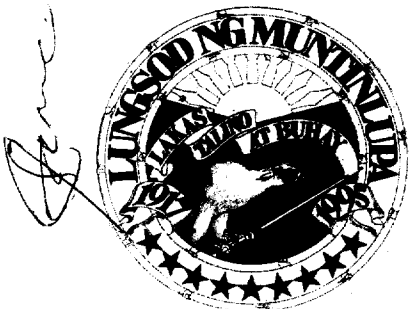
