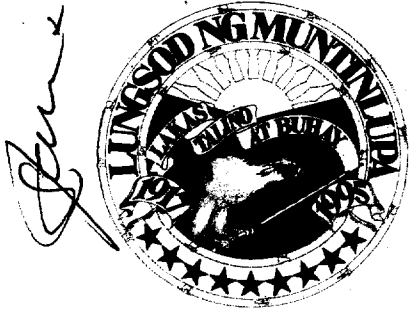
1. *Constitution and By Laws*
