WHEREAS, there is an extension of the *Land Transportations Office (LTO)* in the City Of Muntinlupa located at the DLA Building, National Road, Muntinlupa City since August 1998;

WHEREAS, there is a need to have a regular LTO District Office in the City of Muntinlupa pursuant to *Republic Act 7926, known as The City Charter of Muntinlupa, particularly Sections 54 and 55 herein quoted:*

“Section 54. The City Land Transportation Office – There shall be established in the City a Land Transportation Office, subject to the standards, rules and regulations as may be promulgated by the Department of Transportation and Communications (DOTC) and shall discharge its duties under the general supervision of the Secretary of the DOTC.

Section 55. The City Land Transportation Officer – The City land transportation officer shall be the head of the city land transportation office. He must be a citizen of the Republic of the Philippines, a resident of the City of Muntinlupa, of good moral character, a college graduate, a first grade civil service eligible and must have an experience of at least five (5) years in the field of land transportation or other related work.

The city land transportation officer shall receive such compensation, emoluments and allowances as may be determined by law.

The city land transportation officer shall take charge of the land transportation office and shall perform such duties and functions and exercise such other powers as may be provided by law."

WHEREAS, there are more than three hundred thousand (300,000) people in the City of Muntinlupa and hundreds people in the nearby towns of Laguna who are benefiting the services of the existing LTO Extension Office;

NOW, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Members of the Sangguniang Panlungsod of Muntinlupa to request from the Hon. Pantaleon Alvarez, Secretary of the Department of Transportation and Communications (DOTC) to convert the Land Transportation Extension Office located at DLA Building, National Road, Putatan, Muntinlupa City to a Regular District Office in the City of Muntinlupa.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the Office of Hon. Pantaleon Alvarez, Secretary of the Department of Transportations and Communications (DOTC) and City Land Transportation Officer of LTO Extension Office.
