A RESOLUTION EXTENDING THE CONTRACT OF THE REN TRANSPORT CORPORATION FOR THE COLLECTION OF GARBAGE FROM JANUARY 1, 2002 TO JUNE 30, 2002 UNDER THE SAME PRICE OF SIX MILLION FOUR HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (P6,495,888.00) PER MONTH AND OTHER TERMS AND CONDITONS AND AUTHORIZING THE CITY MAYOR, HON. JAIME R. FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA.

WHEREAS, the contract for the collection of garbage between the City Government and the REN Transport Corporation will expire on *December 31, 2001*;

WHEREAS, the REN TRANSPORT CORPORATION wrote a letter to the City Government requesting to extend the contract and to increase the contract price by ten percent (10%) because of increase in dumping fee, spare parts, wages and other benefits of the workers;

WHEREAS, the City Government grants the request to extend the contract to only six months from January 1, 2002 until June 30, 2002 under the same price of **SIX MILLION FOUR HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (P6,495,888.00)** per month and terms and conditions contained in the existing contract;

WHEREAS, the REN TRANSPORT CORPORATION requested the City Government to extend the contract for the collection of garbage, thru a letter to the City Mayor, pursuant to Paragraph VIII, Sub-paragraph 8.2 of the contract, which states that:

“8.2 at the option of the OWNER and upon conformity of the CONTRACTOR, the contract may be renewed”.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to extend the contract of services of the REN TRANSPORT CORPORATION for six (6) months from January 1, 2002 to June 30, 2002 under the same price of SIX MILLION FOUR HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS (P6,495,888.00), per month and other terms and conditions and to authorize Mayor Jaime R. Fresnedi to sign for and in behalf of the City Government of Muntinlupa;
