WHEREAS, Sitio Bagong Silang, Sucat, Muntinlupa City, home to not less than one thousand (1,000) families, does not enjoy the convenience of electrical post in the area hence, prevalent are the dangling wires and exposed meters which poses danger to its occupants and nearby communities;

WHEREAS, to arrest danger and save lives and properties it is necessary that electrical facilities be installed in the area;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to urge the Manila Electric Company to put up electrical facilities/posts at Sitio Bagong Silang, Sucat, Muntinlupa City.

RESOLVED FURTHER to direct the City Engineer/Building Official to facilitate the necessary documents to achieve this end.
