**WHEREAS**, due to the high level of water of Laguna de Bay brought about by typhoons "Senyang and Reming", residents especially those situated along the Laguna Lake shoreline were still suffering from flooding;

**WHEREAS**, by way of remedial measures, there is a need to immediately dredge the mouth of the Napindan Channel for the purpose of removing the silt and sandbar that hampers the exit of the lake water to Pasig River;

**WHEREAS**, as per study of the Department of Public Works and Highways (DPWH), flooding would last until February 2001 with the water receding by 0.5 cm. per day on only;

**WHEREAS**, the continued presence of this floodwater prevents the beneficial usage of the area and its economic potentials as primary source of livelihood;

**WHEREAS**, it is the duty of every Local Government Unit (LGU) to provide assistance and support to projects initiated by the National Government to ensure effective implementation.

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the City Council of Muntinlupa is *giving its unconditional support* to the Laguna Lake Development Authority's to undertake the immediate dredging of the Napindan Channel/River.

**APPROVED** by the *Sangguniang Panglungsod of Muntinlupa* this 07 February 2001 on its 113<sup>th</sup> Regular Session.
