RESOLUTION GRANTING FRANCHISE TO AYESEL CONSTRUCTION AND DEVELOPMENT CORPORATION TO ENGAGE IN DRAWING OF UNDERGROUND WATER FOR DOMESTIC PURPOSES ONLY AT BARANGAY ALABANG, CITY OF MUNTINLUPA AS PER CITY ORDINANCE NO. 97-24.

WHEREAS, under Republic Act 7160 the Sangguniang Panlungsod is vested with the authority to grant franchise and enact ordinances authorizing the issuance of permit and licenses as well as impose taxes, fees and charges therefor;

WHEREAS, City Ordinance No. 97-24 states that every person, natural or juridical who wish to engage in the business of procuring and drawing of water within the City of Muntinlupa must secure a franchise for its operation;

WHEREAS, the same power is granted under Title 2, Article 20 of Ordinance 93-35, otherwise known as the Muntinlupa Revenue Code;

WHEREAS, *AYESEL CONSTRUCTION AND DEVELOPMENT CORPORATION*, a corporation duly organized and doing business in the City of Muntinlupa with Principal address at Alabang Terminal, Alabang, Muntinlupa City, has applied for a franchise under the same terms and conditions setforth in Ordinance No. 97-24;

WHEREAS, *AYESEL CONSTRUCTION AND DEVELOPMENT CORPORATION*, have successfully and satisfactorily complied with all the requirements provided for under Section 4 of the ordinance mentioned in the preceding paragraph;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to grant franchise to *AYESEL CONSTRUCTION AND DEVELOPMENT CORPORATION* to engage in drawing of underground water for domestic purposes only and not for commercial purposes in the City of Muntinlupa as per Ordinance No. 97-24.
