**WHEREAS**, the Local Finance Committee of the City Government approved Resolution No. 2000-03 on September 26, 2000 recommending the transfer of the City Trust Fund Account from the Philippine National Bank and Land Bank to the Philippine Veterans Bank for better accounting and monitoring;

**WHEREAS**, the Veterans Association of Muntinlupa is also requesting that the City Trust Fund be deposited in the Philippine Veterans Bank;

**WHEREAS**, depositing the City Trust Funds to the Philippine Veterans Bank will benefit the World War II veterans of Muntinlupa because this bank remits 20% of its net income to the Board of Trustees of World War II in the form of grant and aid like free medicines, medical consultation, medical and dental treatment at the VFP Out-Patient Center to veterans, their widows, orphans and compulsory heirs, for educational, social, charitable and rehabilitation purposes and for such other purposes beneficial to the said veterans. The veterans, as shareholders, also received cash and stock dividends annually from the Philippine Veterans Bank;

**WHEREAS**, trust fund includes share of barangays, congressional fund, and all other funds intended for specific purpose.

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, to *authorize* the City Government to *transfer* the City Trust Fund Account from the Philippine National Bank and Land Bank to the Philippine Veterans Bank, Muntinlupa Branch.

**APPROVED** by the *Sangguniang Panglungsod of Muntinlupa* this **23 March 2001**, on its 12<sup>th</sup> Special Session.






