WHEREAS, the Muntinlupa Science High School was established on June 1, 1998 by the Fresnedi administration with a vision of having "an excellent institution of public secondary education where the highly capable youth of Muntinlupa are prepared to become leaders in the scientific field and agents of social transformation";

WHEREAS, the mission of the school is to "provide the qualified youth of Muntinlupa City relevant and high quality public secondary education that will prepare them for careers in science and technology, mathematics and communication arts";

WHEREAS, the Sangguniang Panglungsod of Muntinlupa has passed five (5) resolutions in support of the establishment of the Muntinlupa Science High School;

WHEREAS, the said resolutions authorized Mayor Jaime R. Fresnedi to enter into a contract to purchase parcels of land in Tunasan as site for school (Resolution No. 98-031), contract for the construction of the school building (Resolution 99-064), variation order for the construction of the school building (Resolution No. 99-099), construction of additional third and fourth floors (Resolution No. 20-187) and resolution requesting Congressman Ignacio R. Bunye to allocate the amount of Five Million Pesos (P5,000,000.00) as funding assistance for the Muntinlupa Science High School (Resolution No. 22-233);

WHEREAS, the Department of Education has issued the list of requirements for the establishment of a secondary school through DECS order No. 5, S. 1989;

WHEREAS, among the requirements and the only one that remains to be completed is the Sanggunian Resolution establishing the Muntinlupa Science High School as a new secondary school pursuant to R.A. No. 6655;






