WHEREAS, the *Muntinlupa Polytechnic College* was established in **June 1991** as the first college in Muntinlupa locally-funded and subsidized by the City government;

WHEREAS, in the course of its operation and management, the Finance Committee of the City Government found an urgent need for MPC to have its own separate book of account which it considers crucial to the development of the college;

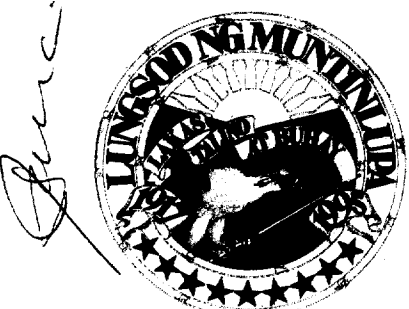
WHEREAS, the Finance Committee has in fact passed a resolution dated October 08, 2001 requesting the City Council to pass a resolution to have its own separate book of account and other financial records which will redound to the benefit of the system of education in MPC;

WHEREAS, the separate book of account will make MPC an independent yet accountable entity of the local government because it will enhance and facilitate decision making on financial matters of the MPC at the school level, but would still be subject however, to the usual rules and regulations of the Commission on audit;

NOW, THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED, that a resolution be passed granting the request of the Muntinlupa Polytechnic College to have its own separate book of account and other financial records pending the enactment of the new college charter;

ADOPTED, by the *Sangguniang Panlungsod of Muntinlupa* this 7th day of *February* 2002, on its 21st Regular Session.
