WHEREAS, the monthly rental is *Twenty Five Thousand Pesos* (P25,000.00);

WHEREAS, the first *Contract of Lease* expired on *September 01, 2001*;

WHEREAS, there is an allocated budget to be taken from the Executive Budget;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod of Muntinlupa duly assembled to authorize Honorable Mayor Jaime R. Fresnedi to sign for and in behalf of the City Government of Muntinlupa the Contract of Lease with Maria Felicidad A. Espeleta over the parcel of land and building located at # 303 National Road, Putatan, Muntinlupa City, occupied by the Land Transportation Office (LTO), covering the period from September 1, 2001 to September 1, 2003 for a monthly rental of Twenty Five Thousand Pesos (P25, 000.00).
