WHEREAS, the association substantially complied with the requirements for accreditation;

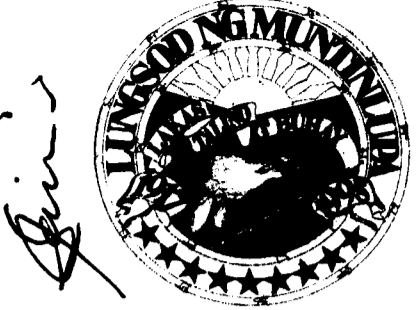
