WHEREAS, among others, the purposes of the said association are:

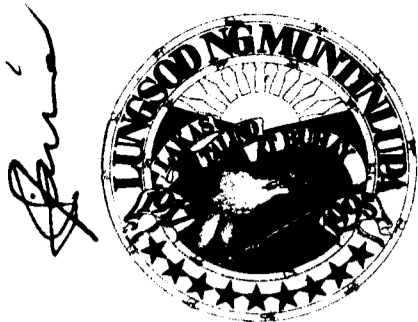
1. To engage in wet and dry market and other services for the members and community at fair and reasonable prices;




