3. To promote the Cooperative as a way of life for improving the social and economic well - being of the members;

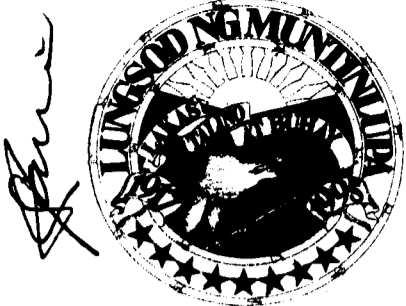
WHEREAS, the association substantially complied with the requirements for accreditation;




