WHEREAS, the LAGUNA LAKE DEVELOPMENT AUTHORITY (LLDA) has the exclusive jurisdiction to issue permits for the use of all waters of the Laguna Lake as per R.A.4850 as amended by P.D. 813;

WHEREAS, the City of Muntinlupa is divided into *nine (9) barangays*, eight (8) of which lies along Laguna Lake. Majority of the residents in this area are marginal fisher folks that rely mainly on Laguna Lake as their primary source of livelihood;

WHEREAS, in order to uplift the living condition of this marginal fisher folk, they deserve to have an equal opportunity to engage in fish cage operation in the territorial water of Laguna Lake within the jurisdiction of the City of Muntinlupa;

WHEREAS, this allocation shall be distributed by the City Government of Muntinlupa through the Lake Management Office to the marginal fisher folks association in every barangays.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVE, by the *Sangguniang Panlungsod of Muntinlupa*, requesting the Laguna Lake Development Authority (LLDA) to grant to the City of Muntinlupa fish cage area allocation of *five (5) hectares* for every shoreline barangay of the City of Muntinlupa.

BE IT FURTHER RESOLVED, that copy of this resolution be immediately furnished the General Manager of the Laguna Lake Development Authority and the Board of Directors of the Laguna Lake Development Authority.
