A RESOLUTION AUTHORIZING HON. MAYOR JAIME R. FRESNEDI TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT THE DEED OF ABSOLUTE SALE TO PURCHASE THE PARCEL OF LAND WITH AN AREA OF TWO HUNDRED THIRTY ONE (231) SQUARE METERS, MORE OR LESS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 207726, FOR FOUR THOUSAND PESOS (P4,000.00) PER SQUARE METER OR A TOTAL OF NINE **HUNDRED TWENTY FOUR THOUSAND PESOS (P924,000.00), LOCATED AT** SUCAT, MUNTINLUPA CITY, TO SERVE AS A SITE FOR THE SUCAT HEALTH CENTER.

WHEREAS, a parcel of land, containing an area of two hundred thirty one (231) square meters, more or less, located at Sucat, Muntinlupa City, registered in the name of Ignacio Nofuente was offered to the City Government for Six Thousand Sixty Pesos (P6,060.00) per square meter, or a total of One Million Four Hundred Thousand Pesos (P1,400,000.00) as site of the Sucat Health Center;

WHEREAS, the City Government requested the lot owner to reduce the price to Four Thousand Pesos (P4,000.00) per square meter, or a total of Nine Hundred Twenty Four Thousand Pesos (P924,000.00), as the said lot is going to be used as site of the Sucat Health Center;

WHEREAS, the said owner of lot agreed to sell the land at Four Thousand Persos (P4,000.00) per square meter as requested by the City Government;

WHEREAS, the Appraisal Committee found out that the market value in the area is between Four Thousand Pesos (P4,000.00) to Four Thousand Five Hundred (P4,500,00) per square meter, and recommended that the City can purchase the lot at Four Thousand Pesos (P4,000.00) per square meter;
