WHEREAS, Section 16 under "State Policies", of 1987 Philippine Constitution states that, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with rhythm and harmony of nature;

WHEREAS, Section 458 (1) (VI) of RA 7160 otherwise known as Local Government Code of 1991, the Sangguniang Panlungsod is empowered to protect the environment and impose the appropriate penalties for acts which endanger the environment and such other activities which results in pollution or of ecological imbalance;

WHEREAS, Section 10 Chapter II of RA 9003, known as Ecological Solid Waste Management Act of 2000 states among others, " Pursuant to the relevant provisions of RA 7160, the Local Government Units (LGUs) shall be primarily responsible for the implementation and enforcement of the provisions of this Act (RA 9003) within their respective jurisdiction;

WHEREAS, Section 2 (b) "Declaration Policies of Article I, Chapter I of RA 9005 known as Ecological Solid Waste Management Act of 2000;

> "(b) Utilize environmentally-sound methods that maximize the utilization of valuable resources and encourage resources

conservations and recovery".

WHEREAS, Section 32 of Article 4, entitled "Establishment of LGU Material Recovery Facility" of RA 9003 states that "There shall be established a Material Recovery Facility (MRF) in every barangay or cluster of barangays;

WHEREAS, the establishment of the City's Material Recovery Facility, requires a five (5) hectares parcel of land;

WHEREAS, the only area that would provide such facility is the NBP reservation area;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod that a resolution be passed requesting Her Excellency President GLORIA MACAPAGAL-ARROYO a parcel of five (5) hectares of land at NBP reservation for the establishment of Muntinlupa Material Recovery Facility.
