WHEREAS, Her excellency, *President Gloria Macapagal-Arroyo* has appointed former *Muntinlupa Congressman and three-term Mayor Atty. Ignacio "Toting" R. Bunye* as the new *Press Secretary and Acting Spokesperson of her administration*;

WHEREAS, the educational attainment of Press Secretary Bunye as a *Political Science graduate, lawyer and Master in Business Management graduate of the Asian Institute of Management (AIM) and former Vice President, Corporate Banking Division of the Bank of the Philippine Islands and Corporate Secretary of Filipinas Foundation and his long experience as former three-term elected Mayor (1988-1998) and Congressman (1998-2001) of the City of Muntinlupa and former Chairman of the Metro Manila Development Authority*, makes him all the more qualified and competent to discharge the duties and responsibilities of such highly sensitive cabinet position;

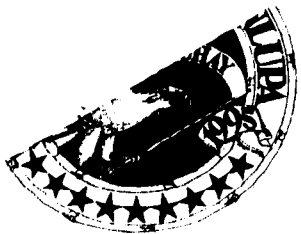
